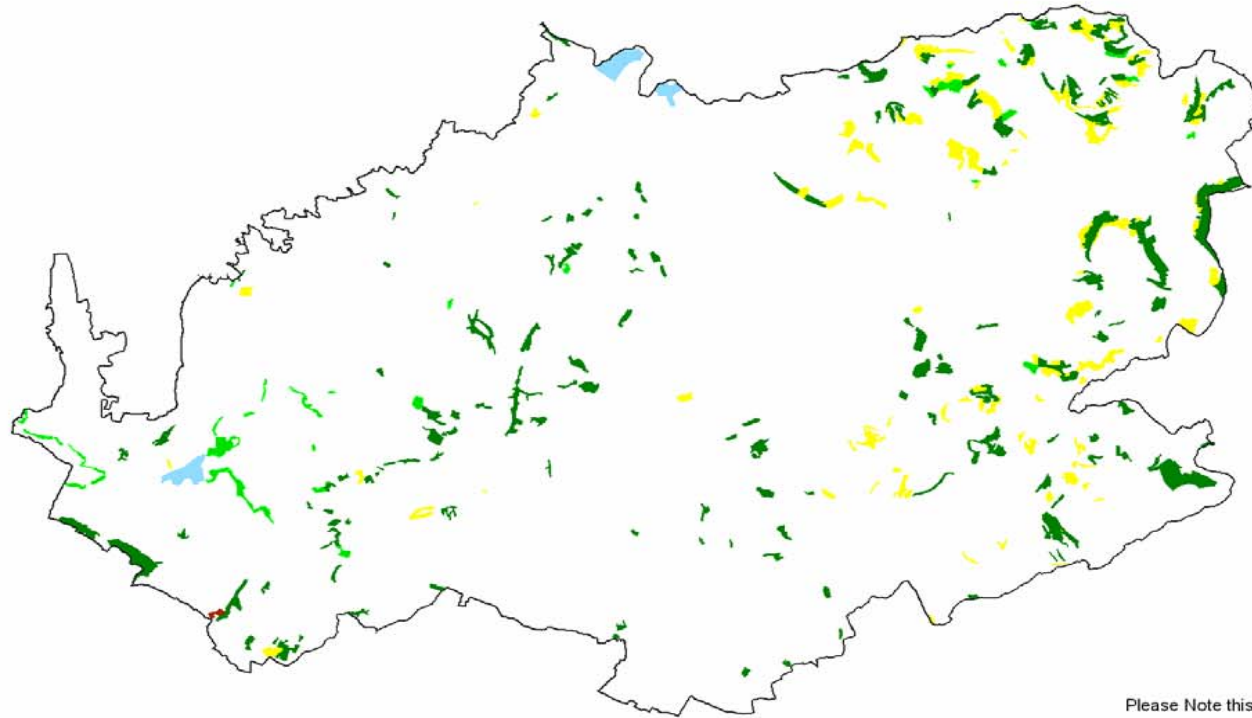
Excluding Woodland

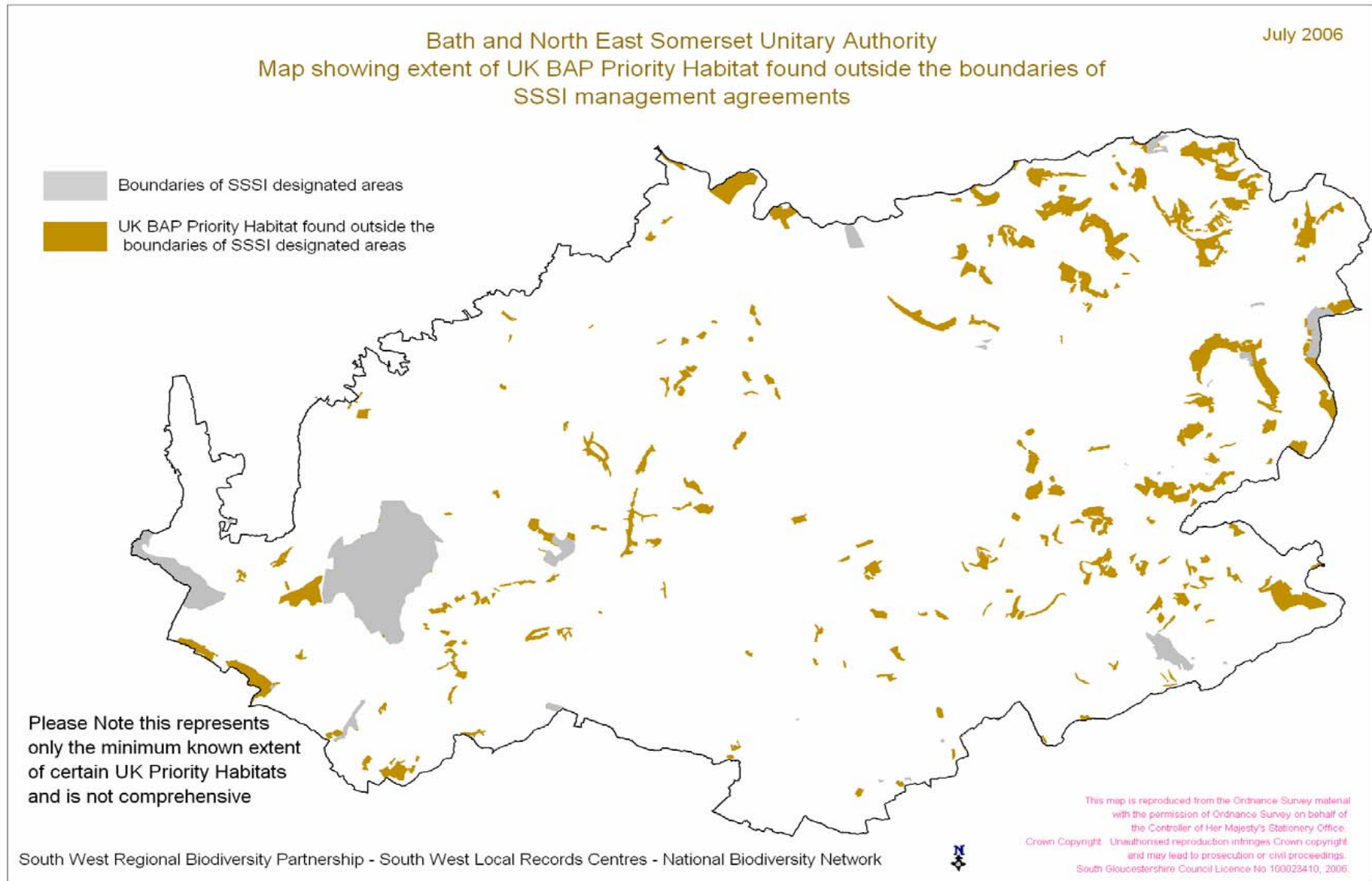






Analysis of UK BAP Priority Habitat within Agri-environment Schemes and SSSIs in South West England

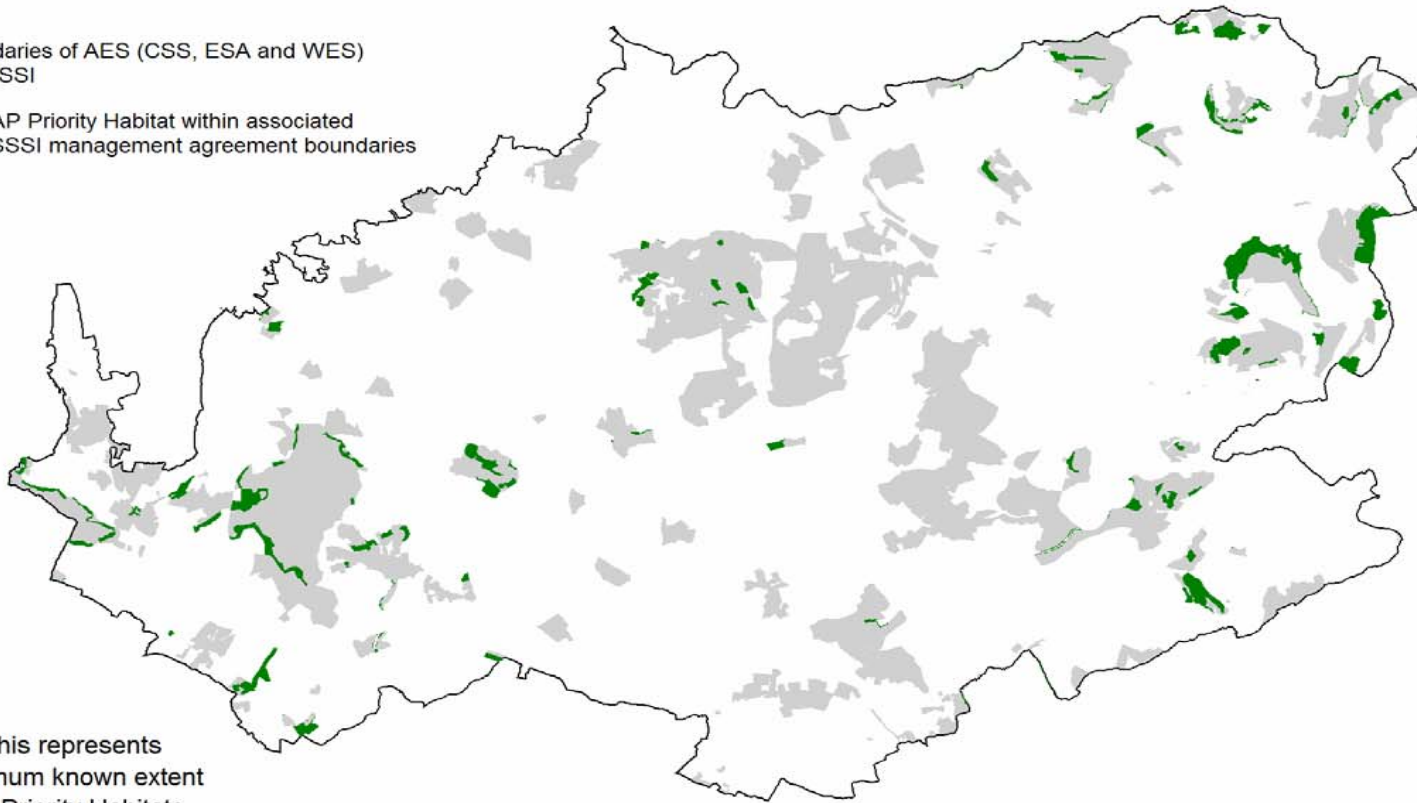



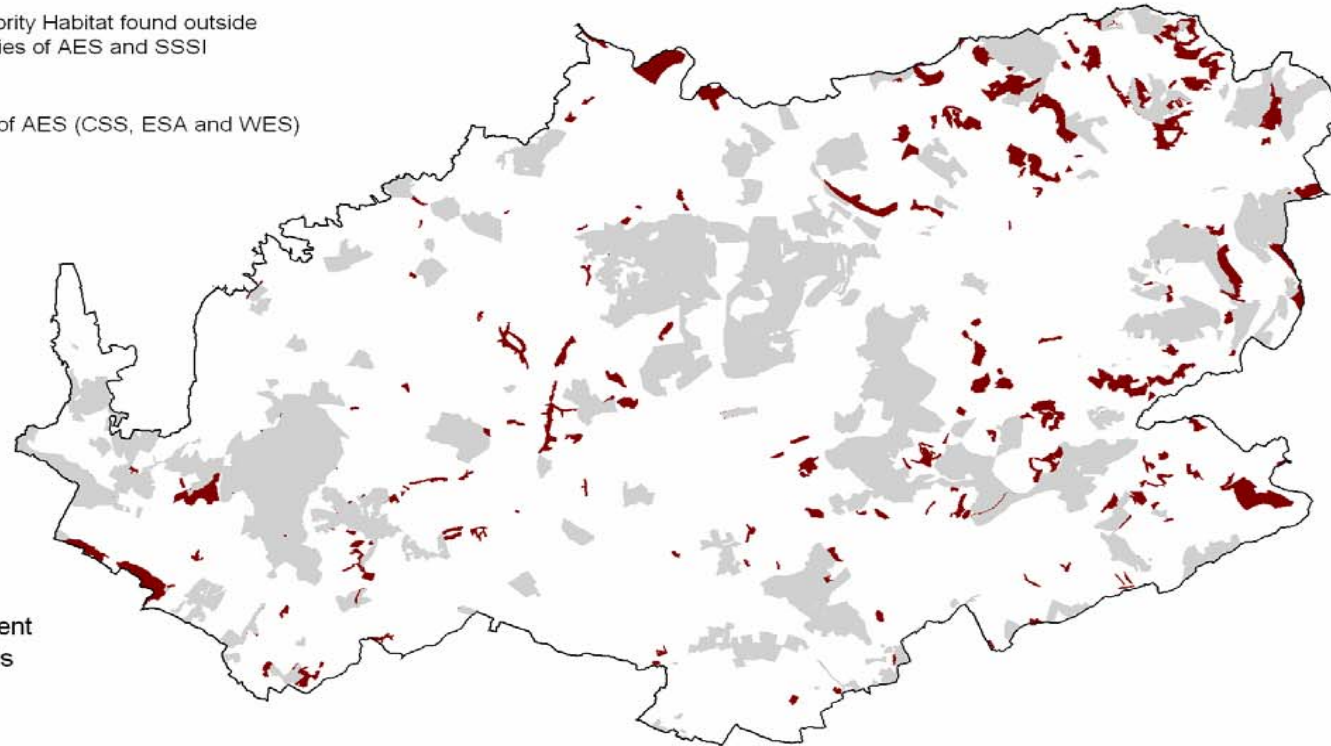
